The Role

Working closely with the Deputy Head of Academic Administration, you will be responsible for the administration of, in general, one of the Mathematical Institute's postgraduate programmes (more information on our courses can be found at https://www.maths.ox.ac.uk/study-here/postgraduate-study). The Mathematical Institute has a large cohort of around 450 postgraduate students, split across 3 research degree programmes and 6 MSc programmes. As part of the 15-post Academic Administration team, you will be expected to work with minimum supervision and prioritise competing demands effectively.



Responsibilities

- To be the **first point of contact** for students, providing advice and guidance relating to graduate student matters, including guidance on visas in line with UKBA regulations.
- To provide **specialist advice and guidance** to Course Directors, Director of Graduate Studies (Taught) and academic faculty on the University Regulations, policy and practice relating to graduate student matters.
- Manage postgraduate admissions administration including interviews and admission processes, liaising with colleges concerning graduate student affiliation, housing, etc. providing information in support of student visa applications and managing CAS information within the University's Student Visa System which is submitted to the UK Borders Agency in support of 'Tier 4' visas.
- Act as lead administrator for, in general, one of the postgraduate taught course programmes, responsible for all **on course administration**, including student induction, updating all course materials and handbooks; maintaining accurate e-vision, GSR and database records, administration of coursework; dealing effectively with all course-related correspondence; organisation of course-related events.
- Responsible for the smooth running of **Examinations** administration, including acting as Secretary to the Chair of Examiners, accurately recording marks, preparing the first draft of the examiners' report.
- Effectively **manage course finances**, including tutor payments through casual payroll, and event budgets.
- **Service committees**, including Supervisory Committee reporting on admissions, examinations, feedback and performance.
- Maintain **good relationships with central academic services** such as Proctor's Office, Education Policy Support, Academic Records Office and MPLS Divisional Office ensuring timely information sharing and good lines of communication.

<u>General</u>

- Responsibility for maintaining information systems. You will need to use initiative to deal with varied and complex queries, in order to collect and present information on a variety of matters, and in order to set up and maintain appropriate record-keeping systems.
- Keep up to date with central policy and regulation updates, maintaining awareness of communications, etc.
- Cover for staff absences as part of the team working within academic administration.
- Other tasks commensurate with the grade, as may be requested from time to time by the Deputy Head of Academic Administration, Head of Academic Administration, Head of Administration and Finance or Head of Department.

- Experience and a good understanding of general administrative practices and procedures;
- Excellent organisational skills to collect, collate, store and disseminate information;
- A flexible approach to tasks and the ability to balance demands, prioritising workload in an efficient and sensible manner in order to meet deadlines;
- Excellent attention to detail;
- Ability to understand regulations and explain them to others;
- Ability to analyse office systems and recommend improvements;
- · Ability to deal with a wide variety of people including academic staff and students;
- Excellent communication skills, both verbal and written;
- Ability to deal with information of a confidential nature;
- Ability to work as part of a team;

• Good IT skills — experience of spreadsheets and databases, preferably within the Microsoft Office suite.

Desirable

- · Experience of administration of educational programmes would be an advantage
- · Experience of eVision, in particular graduate admissions

Our mathematical research, impact and environment have twice been ranked first in the UK, in the 2021 and 2014 Research Excellence Framework exercises, a government review of research in all UK universities. The Mathematical, Physical, and Life Sciences Division

The Mathematical, Physical, and Life Sciences (MPLS) Division is one of the four academic divisions of the University. In the results of the six-yearly UK-wide assessment of university research, REF2014, the MPLS division received the highest overall grade point average (GPA) and the highest GPA for outputs. We received the highest proportion of 4^{*} outputs, and the

highest proportion of 4* activity overall. More than 50 per cent of MPLS activity was assessed as world leading.
