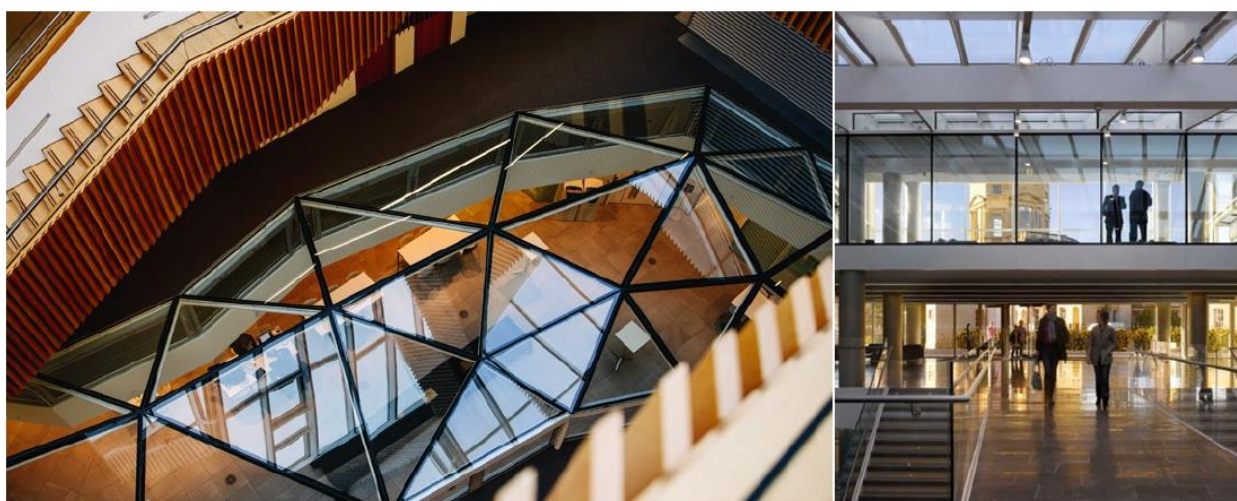

## **The role**

The Mathematical Institute seeks an experienced HR Manager to lead the HR team in delivering a responsive and professional HR service as we support the department's operational needs, and to provide advice and guidance to senior colleagues cross the full HR lifecycle. These activities underpin the success of the Mathematical Institute, a world leading department which has an outstanding reputation for its teaching and research.

This post presents an ideal opportunity to join a thriving academic department in a new role. The HR Manager will lead and manage a team of 5 staff in the coordination and administration of all activities related to the attraction and retention of the very highest calibre of staff into support, research and academic roles.

You will be an experienced, knowledgeable and motivational leader, who will be accountable for the delivery of high quality and responsive support for departmental customers. You will have sound judgement under pressure, be able to think laterally and creatively, and have the intellectual capacity and strength of character to take important, complex, and sometimes difficult decisions. You will already have management experience in an academic (or closely related) environment and experience of leading a support function, and a proven ability to manage change and respond positively to new challenges.

Reporting to the Deputy Head of Administration and Finance, you will work closely with the Department's senior leaders and work in close collaboration with the other operational section heads to ensure that service is consistently of a high standard and supports the department's delivery of its strategic objectives.

The HR Manager will be a member of the Head of Administration and Finance's (HAF's) senior management team and will be expected to provide strategic insights and recommendations for improvements to operations and services generally, as well as to contribute to the development of the department.

## **Responsibilities**

- Lead day-to-day HR service delivery across the department, ensuring excellent support throughout the employee lifecycle and delivering a high level of quality and service across the team. Oversee recruitment operations, staff onboarding, contract management, performance review and reward exercises, and exit processes.
- Provide expert advice and actively support managers to handle individual employee relations (ER) cases including performance, conduct, grievance and absence matters, providing informed, pragmatic and well-judged guidance.
- Ensure the HR team's compliance with employment law, immigration regulations, and university policies.
- Manage the HR Team of 5 staff, taking responsibility for staff recruitment, induction, personal development and workload for all members of the team, ensuring that all staff are appropriately managed and supported and are motivated to perform to the best of their abilities.
- Collaborate with line managers, and coach as necessary, to implement consistent, fair and inclusive HR practices.

- Support and advise the Head of Department with all aspects of academic HR, these will include management and coordination of the Initial Period of Office reviews, employment changes and sabbaticals and other leave arrangements.
- Support the Deputy HAF in delivering staff development, wellbeing, and EDI strategies across the department.
- Review and improve HR processes and workflows, implementing change where needed and championing continuous improvement attitudes.
- Represent the department at HR-related meetings and working groups as delegated. Ensure effective communication with the MPLS Division and University on staff-related matters, and the timely reporting of staff-related data to departmental fora as appropriate.
- Align with the EDI Officer to ensure that departmental working practices and HR procedures and policies are equitable and inclusive.
- Maintain an up-to-date expert knowledge of employment legislation, UK regulatory requirements and HR good practice relevant to the role; actively continue own professional development.
- Any other tasks commensurate with the grade, as requested by the Deputy Head of Administration and Finance

5. Sound knowledge and experience of the application of UK employment law, best practice and current thinking in HR management including in relation to UK Visas and Immigration (UKVI) regulations.
6. Experience of managing employee relations case work within organisational procedures.
7. A commitment to promoting awareness and understanding of Equality, Diversity & Inclusion.
8. Experience of implementing change in a complex environment. A flexible and optimistic approach to the management of change, ever-fluctuating demands and challenging situations.
9. Strong IT Skills, including Microsoft Office and experience of operating HR information systems and ability to learn new systems quickly.
10. Strong communication skills, including the proven ability to influence and persuade managers, and clearly and accurately communicate process, procedure and policy.
11. Excellent interpersonal skills and the ability to motivate, create excellent stakeholder relationships, and work collaboratively within a successful team and with a variety of people.
12. Excellent organisational and time management skills.
